(a) That the company shall charges for minimum 1350 kg/month of solid bio medical waste. If extra weight is picked up from the hospital then @ 35/- kg. shall be charged extra be the company.

9. That the company shall dispatch to the hospital their part of bill on or before 5<sup>th</sup> of every month. The due date for payments by the hospital shall be 10 days of same month. Failure to pay bill by due date shall attract 5% surcharge every month or part their of.
10. That the treatment charges as above agreed by the company and the hospital shall be revised on 1<sup>st</sup> April of every till continuance of the agreement by increasing the charges by 5% compared to previous charges.
11. That since the incinerations and other process involve energy consumption (Power, Diesel or any other source) If any increase in input cost (Diesel Rs. ....per/lt, Petrol Rs.....per/lt.) is reised more than 10% of privilege rate then it shall be directly passed in the same proportion to the member at any time without notice by increasing the treatment cost.
12. That the future if the hospital increase their beds then they should give prior information to the company, monthly charges shall be revised as per the actual bed capacity of hospital. This will be sole right of the company that on any day their representative can visit to hospital and verify the actual bed capacity of hospital.
13. That an advance security deposit of Rs. 45,000/- only shall be deposited to the company by DD no. .... date ..... Bank of India Branch Khudel (Incase if cheque is not cleared or bounced than the whole agreement shall be treated as cancelled) this deposited will be refundable with out interest on termination of agreecment.
14. In according of Medical Council of India (MCI), Dental Council of India (DCI). guideline & permission if hospital expands their bed capacity we shall revised our charges as per MCI, DCI guideline. Hospital shall provide the renewed authorization certificate every year to the company.
15. That the company may at its sole discretion suspend the collection & disposal of waste from the hospital if failed to pay their dues for continues three month. If any member decide to close down their institution they should give prior notice in writing in advance 3 month to company & clear all dues & NOC from pollution control board lock in period for advance deposit will be for 5

If the hospital want to close down the services before completion 5 year then the advance deposit will be forfeited. If the same agreement is revised then the same advance deposit shall be for next lock in period.
