

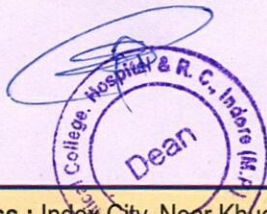

The MTP Act was enforced to improve the maternal health scenario by preventing large no. of unsafe abortions and maternal morbidity & mortality. The PCPNDT Act 1994 was formulated to regulate Pre natal diagnostic techniques and prevent misuse for purpose of sex determination. The POCSO Act was enacted to provide legal framework for protection of children from offences of sexual assault, harassment and pornography for child below 18 years. BMW management rules were revised in 2016. Biomedical waste means any waste which is generated during diagnosis, treatment, immunization of humans and animals.

Module 1: Introduction of Medico-legal Acts. Birth and Death Registration Act, 2006

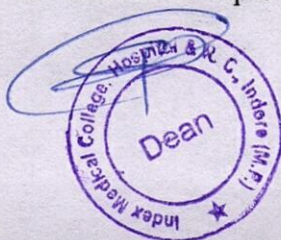
