MEMORANDUM OF UNDERSTANDING

FOR ACADEMIC COOPERATION BETWEEN

INDEX INSTITUTE OF PHARMACY, MALWANCHAL UNIVERSITY, INDORE

&

LAKSHMI NARAIN COLLEGE OF PHARMACY (RCP), INDORE

The Memorandum of Understanding (MOU) establishes the following:

1. OBJECTIVE

To establish a mutually beneficial relationship built on academic and Industry In-demand training programs. Areas of cooperation between the Index Institute of Pharmacy, Malwanchal University, Indore and Lakshmi Narain College of Pharmacy (RCP), Indore include the exchange of Faculties, Skills, Students, Workshops Expertise Sharing, industry oriented indemand training programs.

2. GOALS AND FORMS OF COOPERATION

The signing institutions agree to provide opportunity, as appropriate, for the following activities towards the completion of the objective of this MOU.

- 1. Exchange of Students and Faculties through prior invitation, with the objective in accordance with the procedures and expectation established by each institute and specific department.
- 2. Exchange of training content, study programs, academic projects, seminars, workshop, campus visits and any other data and information of common interest.
- 3. All joint activities will be realized through the mutual agreement and clearly established conditions and mutual obligations of the appropriate institute entity.

3. IMPLEMENTATION OF THE MEMORANDUM OF UNDERSTANDING

The objectives of the MOU will be implemented and regulated in the following manner:

i. Exchange of Faculties / Students for training:

With the objectives of strengthening the students and Faculties, the MOU allow us to arrange the different programs for awareness. The following conditions will apply:

a) The Trainer will maintain their status as Expert at the host institution for the duration of the training program.

- **b)** The appropriate academic department and administrative offices will assist in securing stay and other necessary arrangement for living in the host's institution's city.
- c) The Trainer will make use of the instruments and other facilities available in various departments of host institution after the prior approval.

ii. Training Modes:

Both the institutes will promote advance training through workshops & seminars / lectures.

4. DURATION AND RECINDENCE OF MOU

- i. The agreement shall come into effect from 15/08/2023 to 15/08/2024. Changes to this agreement shall be made by mutual consent between both institutions. In cases of disagreement, the Institute wishing to depart from the agreement shall, wherever possible, give 15 days prior notice of its intention to do so. The agreement shall be reviewed after a period of one year.
- ii. This MOU is being signed purely with the intention of academic betterment and for industry oriented advance training programs cooperation.
